2025-2026 **Dependency Override Appeal**

Under Federal law your family is primarily responsible for paying for your college expenses. In very limited situations Federal law may allow us to consider a dependent student as independent (for financial aid purposes) when unusual conditions exist. Please note: ****Appeals CANNOT be processed until we receive ALL requested documents.**

Examples of unusual conditions where you may be unable to provide parental data include:

Your parents are incarcerated; or

Student's Name

- You have left home due to an abusive family environment; or ٠
- You do not know your parents' location, are unable to contact them, and you are not adopted. ٠

Not all situations are considered unusual. The following would <u>not</u> be considered valid situations:

- You do not live with your parents, or you are self-sufficient; or
- Your parents refuse to contribute to your college expenses; or •
- Your parents are unwilling to provide information on your FAFSA (or for verification purposes); or
- Your parents do not claim you (the student) as an exemption on their income taxes. •

**Verification of your FAFSA information must be completed before adjustments can be made. Regularly check your Eligibility Requirements on your MSU myState and your MSU email address to see documents requested and/or if you need to submit additional documentation. Your appeal will be DELAYED if ALL documents requested are not submitted to our office.

For NEW Appeals, provide documentation as listed in Section A and Section B, and sign this form. For PRIOR Appeals, provide documentation as listed in Section A and Section C, and sign this form.

Section B – Also REQUIRED for <u>NEW</u> appeals:	
A. Professional References	 <u>Minimum of two</u> detailed letters (professional and/or personal): <u>Signed</u>, dated, and listed on agency letterhead. Law enforcement, guidance counselor, social worker, clergy, teacher, etc.
B. Personal References (cannot be a family member):	 Minimum of two detailed letters (professional and/or personal): Signed, dated, and NOTARIZED by a Notary Public. MUST explain how they know you. MUST explain how long they have known you. MUST explain how they know about your situation.
C. <u>Death</u> of one parent or custodial parent, and no contact with non-custodial parent.	 If appeal is due to death – Also provide: Copy of student's birth certificate. Copy of parent's death certificate or full obituary.
D. You no longer live with your parent(s) due to an <u>unsafe home environment</u> (i.e. physical abuse, emotional abuse, alcohol or drug abuse).	 If appeal is due to unsafe home environment – Also provide: Copy of any court record(s). Copy of any police report(s). Copy of any documentation pertaining to situation listed.
E. You no longer live with your parent(s) due to <u>abandonment</u> , <u>incarceration</u> , <u>estrangement</u> or <u>mental incapacity</u>	 If appeal is due to abandonment, etc. in E. – Also provide: Copy of any court record(s). Copy of any police report(s). Copy of any incarceration record. Copy of any documentation pertaining to situation listed.

Section C – Also REQUIRED for <u>PRIOR</u> Appeals (to update):

5. Student **<u>signed</u>** statement **updating** us on the nature of your situation for which we approved the appeal

- a. Indicate the current status as of today (situation is unchanged, reconciliation has occurred, etc.)
 - b. You cannot use a previous student statement.
